**Welcome & Introductions**

Chair Slomka welcomed everyone to the meeting

**1. Previous Meeting Minutes**

The minutes from the September 11<sup>th</sup>, 2008 Technical meeting were revised at the Source Protection Committee Meeting to reflect a correction to page 2, Item II(d), indicating that Dave Ketcheson did leave the discussion however it should be noted as a perceived conflict as opposed to a conflict .

2. (a) Technical project discussions

Don provided background information regarding the Threats and Risk Assessment Project advising that a number of municipalities are undertaking this work on their own while others are looking to the SPC to do the work.

Based on a change in the requirement for this work as a result of the directors rules, and the resulting change in scope of existing projects, there will be some cost saving. Staff are recommending that these savings be used toward the completion of vulnerability ranking. This work will be completed by the existing consultant, Jagger Hims Ltd. doing the work on Threats and Risk Assessment.

There was some concern with utilizing the same consultant rather than going through an RFP process, however given that the re-scoping is a provincial driven change and the work is to be complete in nine months, the staff recommendation is appropriate.

(b) Well Location Survey Project

Don advised that is has come to light that a number of municipal wells have been poorly identified in terms of location. This is apparent when drawing the lines on the maps and some wells are falling outside the lines.

Don indicated that the NVCA and LSRCA are interesting is partnering on a project to have the wells in questions professionally located.

There was a discussion regarding the wells in the Severn Sound watershed and the capture zones.

Don advised that the expectation is to have a discussion at a future meeting regarding the time of travel/capture zones.

3. Consulting support contracts

The next step will be for the review team, which consists of Keith Sherman, Ryan Post, Larry Slomka and Don Goodyear to meet on October 8<sup>th</sup>, 2008 to review and rank/evaluate the submissions. They will then make the selection of the appropriate firms.

4. Presentations - Innisfil Creek Pilot Project

Ryan Post of NVCA made a presentation regarding advanced low water response work completed within the Innisfil Creek subwatershed, relevance to SWP, and next steps for the project.

Lynn Dollin inquired as to when it might be appropriate to have members of the Source Protection Committee participating on the Innisfil Pilot Project Committee as there will be some interest based on the project and its implication on the Source Protection Plan.

Don responded that as the Innisfil Creek is not a source of drinking water it will not have an effect on the Plan however it could provide options related to water quality.

5. Other Business

Dianne inquired about the Latornell Conference and if this is an event members of the Source Protection Committee should attend.

Lynn indicated this should be discussed further at the next SPC meeting.

Dear Mrs. Gillibrand,

Thank you for your letter of August 21, 2008. Your concern for our water is shared by all members of the Source Protection Committee (SPC). Your letter also gives me an opportunity to clarify the role of the SPC, and how it may factor into the concerns you raise.

The Source Protection Committee is made of up 21 members plus myself, appointed as Chair, by the Minister of the Environment on August 20, 2007. Three first nations' representatives are also eligible to sit on the committee, and thus far we have representation from the Rama First Nations. A complete list of the Source Protection Committee members can be found online at [www.ourwatershed.ca](http://www.ourwatershed.ca).

As you may or may not be aware, municipalities have the responsibility for developing waste management solutions for residents, and locally, it is the County of Simcoe that holds this responsibility. The process of selecting Site 41 has occurred over many years, starting with a Certificate of Approval issued in 1998.

Having said that, the Source Protection Committee has begun the process of developing a source protection plan, intended to provide additional safeguards to drinking water supplies. During the development of this plan which will take place over the next four years, land uses that are deemed potential threats to municipal sources of drinking water will be subject to scrutiny through the process described in the Province of Ontario's Clean Water Act (2006). Thank you for your e-mail of September 17, 2008. Your concern for our water is shared by all members of the Source Protection Committee (SPC). Your letter also gives me an opportunity to clarify the role of the SPC, and how it may factor into the concerns you raise.

The Source Protection Committee is made of up 21 members plus myself, appointed as Chair, by the Minister of the Environment on August 20, 2007. Three first nations' representatives are also eligible to sit on the committee, and thus far we have representation from the Rama First Nations. A complete list of the Source Protection Committee members can be found online at [www.ourwatershed.ca](http://www.ourwatershed.ca).

As you may or may not be aware, municipalities have the responsibility for developing waste management solutions for residents, and locally, it is the County of Simcoe that holds this responsibility. The process of selecting Site 41 has occurred over many years, starting with a Certificate of Approval issued in 1998.

Having said that, the Source Protection Committee has begun the process of developing a source protection plan, intended to provide additional safeguards to drinking water supplies. During the development of this plan which will take place over the next four years, land uses that are deemed potential threats to municipal sources of drinking water will be subject to scrutiny through the process described in the Province of Ontario's Clean Water Act (2006). This is a locally driven, science-based, multi-stakeholder process designed to protect municipal drinking water sources and promote stewardship.

# Source Water Protection Monthly Communications Report September 2008

## COMMUNICATIONS ACTIVITIES

A press release is scheduled to be released as soon as we've received approval from the Ministry of Environment on the Tier 1 Water Budget Reports for LSRCA and NVCA.

The municipal council e-newsletter has been drafted and is presently in editorial. It is anticipated it will be distributed during the week of October 14.

Work with our SPR partners has been ongoing to coordinate the collection of council resolutions endorsing the expanded protection areas (2 year time of travel around wellheads and IPZ 1's around intakes) for the purposes of the Ontario Drinking Water Stewardship Program.

A "Request for Quotation" is underway to seek external assistance with the municipal workshops planned for 2009.

Work is still in progress to finalize the Communications Strategy and list of contacts (community groups, chambers of commerce).

## EVENTS

On September 17, SPC Chair Lynn Dollin spoke at a York Region conference (2nd annual) entitled "Environment First". Approximately 100 people attended - most were staff from York Region or their member municipalities. There were a wide variety of speakers with the focus on planning for environmental sustainability in York Region. Erin Mahoney was one of the organizers and Ilmar Simanovskis was also in attendance. The presentation was very well received and a suggestion was made to have it posted to our website, which is being pursued.

On September 17, Don Goodyear presented to the Wasaga Beach Chamber of Commerce where approximately 12 members attended. The crowd was attentive but asked very few questions.

Source Protection staff and one committee member attended the Georgian Bay Waterworks Association conference on the evening of September 30 and morning of October 1 at the Nottawasaga Inn in Alliston, Ontario. It was a well attended conference with over 200 delegates; it was considered a worthwhile event to attend in future.

**"Compensation" included in one source water proposal; Committees across the province are submitting their terms of reference proposals to the Minister**

Source water protection committees across the province are nearing completion of their Terms of Reference. At least one proposal will be submitted to the minister next month with reference to the controversial issue of "compensation" included in the text.

The Ausable Bayfield/Maitland Valley Source Protection Committee (SPC) approved terms of reference that note "Funding mechanisms for implementing land use policies on private land will be identified and included in the source protection plans."

"Financial implications, including compensation, financial assistance, and incentives for land use restrictions will be researched by the SPC."

Keith Black, a farmer from Belgrave who represents agriculture on the AB/MV Source Water Protection Committee, said he wanted to see the word "compensation" in the proposal "in writing, because that was the way the agricultural groups felt, that compensation should be in there."

"We hope it will be approved," said Black.

The Terms of Reference have been forwarded to the AB/MV Source Water Protection Authority for a further comment period. But they can no longer be amended. Any further comments will be attached to the proposal when it's forwarded to the Ministry of the Environment, in mid-October.

The minister has three options, explained Cathie Brown, the project manager for the Source Protection Planning Committee. He can approve the proposed terms of reference; unilaterally amend them, or return them to the source protection committee with recommended amendments.

"SPCs have been advised that it would not be appropriate to include in the terms of reference, tasks related to the development of compensation for land use restrictions," Paul Heeney, the manager of source protection implementation for the Ministry of the Environment, told Ontario Farmer.

However, Heeney added in an email "It may be appropriate to include tasks relating to research on the impact of proposed source protection policies."

Ultimately, however, "the Clean Water Act provides that a decision to approve Terms of Reference is the Minister's to make and we cannot pre-determine the Minister's decision on specific tasks."

"I think the only way we're going to get compensation per se, is for the agriculture groups to put enough pressure on the minister and MPPs, to change the act," said Black.

To that end, the Ontario Federation of Agriculture has asked each of its members to contribute \$1 to fund a legal review of the legislation.

"We put out a call to county federations and we've heard back from several. We've also had several individuals contribute," said Dave Armitage, OFA's head of research.

"We've developed a request for proposal. We're optimistic that we will at least get the funding required for a legal review to advise on next steps."

Each Source Protection committee is working on slightly different timelines, depending on circumstances in the region.

Heeney reported that, of Aug. 20, 14 source protection committees were at the same stage as AB/MV, having forwarded the proposed Terms of Reference to their local Source Protection Authority and posted them electronically, providing for a second public comment period.

Four committees have just completed their first stage of public consultation on the draft proposals, which may result in amendments.

Five committees have requested and received a two-month extension and a sixth request for extension is under consideration by the ministry.

**Local residents voice environmental concerns about 70,000 dumped tires**

Ask Ed Beach how many discarded car tires lie buried in two ravines on his picturesque century-old farm on the Oak Ridges Moraine, and his initial response is: "A few thousand tires."

But that's not exactly a universally accepted, comprehensive tally.

Ministry of Environment spokesperson Kate Jordan says the real number is as high as 70,000. That was the estimate in 1999, when the province allowed him to cover them with fill "for the purpose of soil erosion control."

Beach, a cattle farmer, says the tires have been accumulating on the family farm since Hurricane Hazel in 1954 through the 1970s, to shore up ravine walls.

The province was prompted to permit burying them out of fear the farm could fall to the same fate as a Hagersville tire dump that famously caught fire and smouldered noxiously for 17 days in 1990.

Nearby residents and environmental activists question the wisdom of that decision and the long-term environmental impact. They fear chemicals may be leaching out of the tires, through the moraine's sandy-gravelly soil, and into groundwater that feeds local wells. The area is one the province considers environmentally sensitive.

The issue raises questions about who has been, or should have been, monitoring Beach for the past nine years as he's brought in thousands of truckloads of fill to build a giant berm.

Complaints have prompted the Town of Uxbridge to investigate whether the amount and type of fill Beach is dumping on his farm today is justified under the provincial permit to keep the tires covered – or whether he should have also had a local fill permit.

"Everything has been done legally," Beach told the *Star* during a recent tour of his farm near Concession Rd. 2 and Wagg Rd. in Uxbridge, Ont.

Beach says he doesn't believe there is any threat to the groundwater.

That's hogwash, says Anne Holmes, a local activist who campaigned unsuccessfully for mayor.

She points out that the moraine aquifer, which the province regards as highly vulnerable, is part of the Oak Ridges Moraine, the source of drinking water for more than 200,000 people.

"I want these tires removed and shredded," said Holmes, who supplied the *Star* with a copy of a video that surfaced recently, showing the farm years ago, before most of the tires were covered over.

"If we are going to allow this to remain, what are the effects on the drinking water?"

The video casts doubt on whether the tires were used only for erosion control as advertised – or indiscriminately dumped. It shows thousands of tires strewn, not just inside the ravine walls, but also along the flat tableland above the valley. In some cases, mature birch trees can be seen growing up through stacks of tires obviously long in place.

But the tires are better off under the ground than on top, Jordan says, since they appear to degrade very slowly.

"The information I have from the district, based on the reports they've given us and based on the inspections we've done, is that there is limited leaching of any contaminants, and therefore there are no groundwater concerns related to this," she said, although she later acknowledged no testing of area soils or water had been done.

There seems to be little scientific data as to when and how leaching might become a concern with tire dumps.

With discarded tires now banned from municipal landfills – owing to fire concerns – and most now recycled, such stockpiles usually date to an earlier era.

Several researchers and scientists in Ontario and the United States confirmed that rubber itself is extremely slow to degrade, especially when not exposed to the elements.

But they said it's more difficult to say whether toxic additives used to make tires, such as plasticizers, will leach out if they're buried.

The Rubber Association of Canada agrees with the province that the big concerns with tires are fire and mosquitoes, not leaching.

But Ramani Nadarajah, a lawyer with the Canadian Environmental Law Association, warns that, "There's always the potential for contaminating groundwater."

The only way to be certain is to test the area water and soil, she says.

She pointed to a 1991 case that's still not entirely resolved involving a similar ministry-supervised plan to bury about 33,000 illegally dumped tires in a water-filled trench in Egremont Township in Grey County.

When ministry officials tested the water in the trench less than a decade later, they found levels of contaminants in excess of provincial guidelines. A cleanup was ordered.

The Canadian Environmental Law Association says that NDMA – found in rubber products, pesticides and dyes – is of particular concern because it is a potent animal and human carcinogen and its decomposition rate in water is unknown.

Other questions linger about the fill Beach continues to bring in long after most of the tires were covered.

Standing next to piles of fill accumulated over the past year, Beach explains that his family has been battling erosion for decades because runoff from several nearby properties flows on to his farm.

He points to an area where what was formerly a deep ravine now stands completely filled in and grassed over. There is no sign of the original valley.

There's a second ravine, about 22 metres deep that he says he must continue to fill. He says it will allow him to build a road to reach the first covered valley, where some surface and grading work has yet to be finished.

He's also building a giant berm that he says is needed to stem effluent from a neighbouring cattle operation.

Beach says town officials have consistently told him he doesn't need a local fill permit.

"On any given piece of property, you are allowed to push dirt wherever you want," Beach says. "Where you run into problems is if you take dirt from one property and move it to another."

Uxbridge town clerk Debbie Leroux says local bylaws do regulate the dumping and placing of fill, as well as altering the grade of the land. Responding to complaints, officials are now trying to figure out what Beach is allowed to do under his provincial permit.

Jordan said Beach has recently offered to provide ministry staff with soil analysis results he will conduct to determine whether the fill meets ministry standards.

Beach says he's never been asked to report to anybody exactly how much fill he has trucked in over the years, saying he would have to do some calculations to figure that out. He figures that as many as 1,000 trucks a year have continued to bring construction fill to his farm.

"The property owner is required to submit an annual report on its progress to clean up unwanted tires," Jordan says of the provincial regulations. "However, there is no requirement for an annual report on the ongoing maintenance of the site."

**City water checks out OK; Province announces funding for protection planning;

A project to assess and protect the sources of Sault Ste. Marie's municipal drinking water has so far found no chronic threats of contamination.

"What we're doing is helping make sure any threats (of contamination) that may exist before water gets to the distribution system are actually dealt with at the source," said Rhonda Bateman, drinking water source protection planning co-ordinator with Sault Ste. Marie and District Conservation Authority.

The program, launched across the province in the wake of fatal E coli bacteria contamination in Walkerton, Ont's municipal system eight years ago, is being carried out by conservation authorities with funding from the province.

MPP David Oraziatti announced this year's funding for the local project on Thursday.

Bateman said the \$371,543 announced represents roughly 75 per cent of the project's annual operating costs. She expects further funding. This year's amount is actually lower because money allotted last year was carried over.

So far, \$2 million has gone into the source protection project in the Sault. The tally should ring in at \$4.09 million, at the project's conclusion in 2012. The program began in 2004 and has since doubled the Conservation Authority's complement of staff.

Right now, the Conservation Authority is working on multiple technical studies to characterize the watershed and find any threats to the Sault's municipal source water system, said Bateman. "Nothing currently has been identified as being a chronic threat."

Part of the study is identification of potential problem areas, including land uses such as agriculture and industry.

When the science is done, the project will develop a protection plan for the area, said Bateman. That plan should be in place by the end of 2012.

The source protection program only deals with the municipal system, roughly half of which comes from the surface water intake on Lake Superior at Gros Cap, and the remainder from groundwater. But any progress made by the program should also decrease threats to those who take their drinking water from their own wells, said Bateman.

The land area under the jurisdiction of Drinking Water Source Protection is 522 square kilometres. The area comprises Sault Ste. Marie, Prince Township, parts of Dennis, Pennefather, Aweres, Jarvis and Duncan Townships, and portions of both the Garden River and Batchewana First Nations. When Canadian waters of the St. Mary's River and Lake Superior are added, the total area under Source Protection swells to 775 square kilometres.

### **Shame on Dion for exploiting Walkerton tragedy**

### **Potential for enormous costs**

Ever since Ontario's Source Water Protection legislation was being considered, it has sparked debate and concern throughout the province.

Farmers and their organizations have identified some of the potential costs for farmers as a result of the legislation and those costs could be enormous.

They have also identified the many inequities farmers could be exposed to as a result of the legislation and the resulting Clean Water Act.

"At this point, we don't have a clear indication of how many farm properties might be declared high risk," advises Mark Wales, member of the Ontario Federation of Agriculture Executive Committee.

The Ontario Federation of Agriculture recently attended a meeting in Kingston, Ont., where Environment Minister John Gerretsen was speaking about the Clean Water Act.

"Compensation has become a word even the minister doesn't want to use when speaking of the act," notes Wales, "and the contributions of so many people to the protection of drinking water sources."

He told attendees there would never be enough money to compensate people for the things they may have to do and affected people will just have to live with it.

"Other comments from the minister gave hope to those attending the meeting that financial assistance could be provided through stewardship funds under the act."

'Precautionary principle' has been a term long associated with the legislation. It essentially means to err on the side of caution.

"If the ministry moves to include broad definitions of risk in the act and the associated regulations, the precautionary principle would bring a large number of farming properties into the definition," suggests Wales.

"If, however, the legislation and regulations are tightly written to ensure only situations posing specific risk to the drinking water systems, the number of affected properties would be much smaller."

OFA's greatest concern with this process and the minister's comments is that the largest possible number of farm properties will be drawn into the source water protection process at considerable and unnecessary expense to farmers.

"If we compare this process to the purchase of insurance, we understand and appreciate that the more precautions we choose to cover, the more the insurance premium will cost," says Wales, who farms in the Copenhagen area.

With the source water protection process, however, the province and conservation authorities are engaged in assessing the risks, but then will direct the affected citizens to cover the costs of reducing that risk.

"From the Kingston meeting, it appears to OFA that farmers, as majority property owners, are being targeted by the government in this potentially burdensome legislation."

During a slide presentation at the meeting, agriculture, its people and its practices were mentioned at least nine times.

The spreading of biosolids on farmland, a practice approved, monitored and regulated by the ministry of the environment, is included in the government's list of risks to drinking water sources.

"Does this tell us something about the ministry's approach to protecting drinking water sources for the citizens of Ontario?" questions Wales.



"Minister Gerretsen's comment that there would never be enough money to compensate people for what the government is expecting them to do tells us he recognizes the unaffordable costs that will be imposed."

Farmers have always used best management practices to minimize their impacts on the environment. The OFA believes greater government involvement is essential, through the stewardship funds and direct compensation to farmers.

"Farmers can't afford to continue funding activities that benefit all citizens," warns Wales.

### **Heavy rains threaten drinking water: scientist**

The intense and sporadic rainfall events experienced across Ontario this past spring and summer are a growing reality in the face of climate change, says a leading scientist.

These events lead to greater soil erosion and runoff, potentially contaminating water, something of particular concern in Guelph and surrounding areas where drinking water is sourced from groundwater, Jim Bruce said yesterday during the eighth annual Grand River Watershed Water Forum. Bruce is also a member of the Soil and Water Conservation Society.

He called for greater government monitoring of wells and water courses to avoid contamination from phosphorus, chemicals and other pathogens.

"The washing of chemicals, bacteria and nutrients into groundwater systems is a serious health issue," Bruce said.

Extreme weather events caused by climate change, he said, will make it much more difficult to meet water quality initiatives, such as those under the 2006 Clean Water Act.

"There are enormous implications for people in this region," Bruce said.

Clean-water initiatives and in particular the development of source water protection committees - on which municipal and conservation authority representatives sit -- was a major focus of the Annual Report on Drinking Water released by Ontario's Environment Minister John Gerretsen during the water forum.

The committees will eventually release source water protection plans for regions across the province, detailing all the hazards to drinking water sources, remediation efforts and funds available to landowners whose properties are affected.

Speaking to the assembled audience, Gerretsen released the report that essentially summarizes all the drinking water initiatives over the last year. He touted source water protection committees as the right step toward the monitoring needed.

"The source water protection committees, their main purpose is to make sure the sources of water supplies in this province are protected in the best possible way," he said.

"But it's just a start, once these plans are in place we need to make sure these plans are being adhered to."

Many at the forum warned of the need to act now, before it is too late and the demands from a growing population increase.

Isobel Heathcote, University of Guelph professor of environmental science and engineering, touched on that point, tackling the issue of population growth and water use as the forum's first speaker.

"It should be simple, but it's not," she said, adding that despite knowing populations in Guelph and surrounding areas will grow, the exact demands the new people will place on water are unknown.

Regardless of how clean or ample the source, all water will always go through a treatment facility. The high quality of Ontario's drinking water, since Walkerton, was also a highlight of the drinking water report.

While not advocating for or against a bottled water ban, Gerretsen said all Ontarians should drink tap water.

"Water that is in a municipal system through the province of Ontario is in excellent shape and I would want people to drink tap water. It's good water, some of the best water in the world," he said.

**Midland council likes its plastic  
Water bottle sales ban defeated in 4-4 tie vote

A motion to ban the sale of disposable plastic water bottles in town facilities, including office buildings and arenas, where access to town water is available was defeated Monday in a 4-4 tie vote at Council.

Coun. Gordon McKay, who introduced the motion, said afterward that he was "disappointed, but not terribly surprised by the result."

In what is becoming a voting pattern on some issues, councillors Pat File, Zena Pendlebury and Stephan Kramp voted for McKay's motion, while Mayor Jim Downer, Deputy-mayor Ruth Hackney and councillors Judy Contin and Jack Charlebois voted against it. Coun. Bob Jeffery was not at the meeting.

Letters from both Nestle Waters Canada (questioning the merits of the ban) and The Council of Canadians (supporting it) were read, but neither appeared to have much influence on the outcome.

McKay focussed his bid for support of the motion on what the ban would "mean to Midland."

Noting there are no water fountains at the North Simcoe Sports and Recreation Centre, he said people spent about \$14,000 last year for bottled water at the facility.

"We (the town) made \$9,000 in profit," he said. "If we provided fountains we wouldn't be taking money from the pockets of the public."

He also suggested 50 per cent of the bottles sold at the NSSRC go into the blue box recycling program, which is 73 per cent paid for by the public. The remaining 50 per cent go to landfill, he added, and "each bottle is like a shovel in (the ground) of Site 41.

Deputy-mayor Ruth Hackney said the motion was premature.

"We have a 10-year contract with Pepsi (at the NSSRC)," she said, noting Pepsi bought three scoreboards at a cost of \$30,000 among a number of other financial commitments -- including an annual donation of \$500 worth of product to minor hockey for 10 years.

"To pull that contract would be detrimental to the public," she said. "We need more research."

McKay countered that his motion would simply set a direction and that the town could talk with Pepsi.

Coun. Judy Contin recalled that when the NSSRC was built there was "a health and safety issue around water fountains," which require frequent cleaning. She listed a number of locations within the complex that would require fountains if bottled water sales were banned.

"People can't bring other drinks to dances at the NSSRC and this would take away their choice. The NSSRC has a good recycling program," she said. "This (motion) is wrong."

Coun. Stephan Kramp said the use of bottled water increased following the tainted water tragedy at Walkerton.

"It's use is only reinforced when councillors consume bottled water," he said.

## **Residents want water-taking proposal stopped**

Grey Highlands council heard a loud and clear message from its residents at a special planning meeting Monday afternoon: no more water taking.

A massive audience filled the council chambers in Markdale and spilled out in the office's reception area. The crowd was on hand for a public meeting about a proposed water-taking venture in the geographic area of Osprey Township. The proposal would drain up to 112,320 litres per day from property close to the border with The Town of The Blue Mountains.

A massive contingent of ratepayers from both Grey Highlands and The Blue Mountains were on hand to express complete opposition to the proposal. The proposal requires a Grey County *Official Plan* amendment, a Grey Highlands *Official Plan* amendment, a Grey Highlands zoning bylaw amendment and a *Site Plan Control* agreement.

At the meeting, speaker after speaker condemned the proposal and said enough water was being pumped out of the ground by another water bottling operation in Feversham. They said enough was enough and it was time for Grey Highlands council to make a stand and stop such undertakings.

The municipality received dozens of letters about the proposal called Paradise Springs.

Monday's meeting was the second public meeting held about the proposal. A previous meeting was held in May 2007 on the same proposal and the entire matter was put on hold until the proponent provided more studies and information required in order to allow the application to move forward.

Grey Highlands Planner Lorelie Spencer said a number of concerns had to be addressed on the property before she would recommend approval for the O-P and zoning amendments. The biggest concern for the municipality focused on roads in the area.

Paradise Springs plans to pump water at that location and truck it to another location. Proposed haul routes are a serious issue for municipal officials. Grey Highlands wants the proponent to pay for a number of serious road upgrades before allowing the proposal to move forward.

Spencer also said an accurate Site Plan had not yet been submitted to the municipality.

For the residents at the meeting the biggest concern was the impact the proposal would have on the surrounding area. The rezoning would change the property from rural to light industrial. At the meeting speaker after speaker denounced the proposed planning change pointing out that an industrial use in a rural residential area is completely inappropriate.

Other residents said they were tired of this area's water resources being exploited by companies looking to make a quick buck.

"There will be no contribution to our local economy with this. It's strictly the removal of a resource for a substantial profit," said one resident.

Bill McMurray told council they were just facing a planning matter with the application.

"This is a moral issue for you. Don't tarnish your image by approving this. Even a thimble full of water is too much," he said.

Eugenia resident Larry Mann said another water taking company in the area wasn't needed.

"What value does water bottling have for our community? This serves no purpose," he said.

A number of citizens questioned the relatively small amount of water Paradise Springs was asking to pump. Paradise Springs planning consultant Dave Slade said 112,300 litres was about the same amount of water that's in a swimming pool. Several residents said they believed the application before council is just the start of the process.

"These things start small. I'm sure when Ice River Springs started it was small," said Emily Black. Another resident pointed out that another commercial water taking operation - Gilbralter Springs went out of business with a permit to take more than 700,000 litres of water.

Neighbouring property owner Amanda Knight said she couldn't believe she was seeing the possibility of land near her home being re-zoned for industrial purposes.

"We moved into the area thinking we wouldn't have an industrial area right next door. It was the last thing we expected," said Knight. "Why are you even considering re-zoning this property to a commercial water taking operation let alone any other industrial use?", she said.

John Hartley said the municipality is only going to create future problems for itself if it approves the re-zoning.

"There is no reason for council to consider the zoning and changing the *Official Plan* for a small operation that becomes a monster later on," he said.

Jim Bachelor said there were other places for a company to get water.

"Tap into the municipal water system in Barrie and take your swimming pool amount out of there," he told the proponents.

Slade explained to the audience that the proponent had received a permit to take up to 112,300 litres per day from the site. That would require three truck loads a day, seven days a week.

Slade also explained that the operation did not have plans to pump water from the ground.

"This is a spring. It's water that's coming to the surface," said Slade. "This is a very small application and all we can do is follow the guidelines. Water can be removed from this location and not affect the deep reserve," he said.

Grey Highlands council did not make any decisions on the matter at Monday's meeting. The municipality must first wait for Grey County to make a decision on its *Official Plan* amendment before proceeding with the matter.
