(a) Governance in the First Nation

Dan Shilling, First Nation Manager of Rama First Nation, presented on the governance of the First Nation, as well as goals and challenges. Mr. Shilling extended his thanks to the SPC for the work they were doing, and answered a number of questions generated through his presentation.

(b) History and Traditions Relating to Water

John Snake, Culture Coordinator of Rama First Nation, presented on the Rama First Nation history and traditions relating to water. John welcomed the SPC in the

traditional language, and conveyed to the SPC the importance of water to the community.

(c) Rama First Nation Infrastructure and Water and Waste Water Operations

Fred Jahn, Director of Facilities & Operations of Rama First Nation, presented on the community's infrastructure, water and waste water operations. Mr. Jahn also provided a summary of the First Nation's work relating to Source Water Protection and enforcement.

Fred Jahn presented to the SPC on the management of the Rama First Nation water/ waste water treatment operations, including the use of independent inspectors to Ministry of the Environment (MOE) standards, and best practices employed. The system of management within Rama First Nation, and the responsibility of the water treatment plant residing with the Chief and Council, practicing the higher standard of regulations.

Chair Stan Wells thanked the Rama First Nation for sharing their knowledge, passion and history with the SPC, and noted the many similarities in the goals of the SPC and the First Nation community in protection of water resources.

**RESOLVED: THAT the presentation by the Rama First Nation Community on: Governance and goals of Rama First Nation; The Rama First Nation history and traditions relating to the water; Rama First Nation infrastructure and water and waste water operations; and summary of work relating to Source Water Protection and Enforcement on the Reserve be received for information.**
